1. Name of the Society Sh. Bholi Ram Memorial Education Society.
2. The regd. office of the society shall remain in U.T. of Delhi and at present it is at:- 12, A Village Nangli Sakrawati Najafgarh New Delhi-110043.
3. Aims and objects The aims and objects for which the society is established are as under:-

a) To arrange establish, open and run educational and vocational schools or institutions and to bring the education within the reach of poor and backwards children in the Union Territory of Delhi.

b) To impart the education to the poor, helpless and needy children/students.

c) To spread and provide education in healthy atmosphere and through latest modern scientific techniqs and methods to the needy and deserving students.

d) To carry on experiments with a view to improve methods of imparting instructions in the fields of education and to facilitate the training of students in all stages of education.

e) To provide libraries, publish books on educational and social subjects, organise discussions and seminars to promote knowlege and undertraining amongst the people.

f) To raise fun is through grants, donations, subscription, loans atc for the attsinment of aims and objects of the society.

RULES AND REGULATIONS

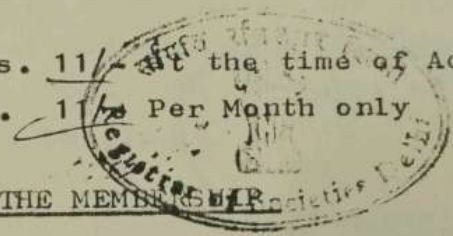
6Bhelli Ram Memorial Education Society

1. Membership:

If the membership is refused to a certain person or persons the reasons of refusal shall be communicated to the person(s) concerned.

2. SUBSCRIPTION:

Admission fee Rs. 11/- at the time of Admission  
Subscription Rs. 11/- Per Month only



3. TERMINATION OF THE MEMBERSHIP

The Governing body shall have the power to expell a member from the ,society on the following terms and conditions:-

a. Majority of votes of general body meeting.

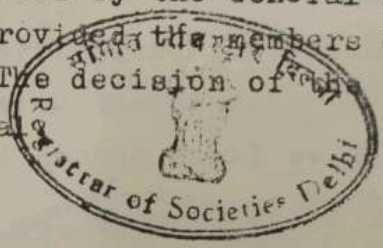
- b. On his-her death.

- d. On his/her written resignation.

- f. The reason of the termination from the membership shall be communicated to the member(s) concerned.

4. APPEALS:

All the appeals shall/should be preferred to the Governing Body of the Society. The decision of the General Body shall be final. The reason for rejection shall be communicated to the member concerned.

5. RE-ADMISSION

In case of member is expelled by the General Body, the same can be re-admitted provided the members concerned pays all upto date dues. The decision of the General Body shall be final.

7. GENERAL BODY

All the members of the society will constitute the General Body of the Society.

FUNCTIONS OF THE GENERAL BODY

1. To consider any a business brought forward by the Governing Body.
2. There shall be an annual meeting of the General Body in the month of March, every Year.
3. Not less than 15 days prior notice shall be given to the members before the date of General Body meeting enclosing the agenda specifying date time and place and quorum shall be 2/3 rd.

9- SOURCES OF INCOME.

- a. Admission fees
- b. Subscriptions
- c. Donations and special contributions.

The income of the society received from all the sources shall be utilised only for the promotion of its aims and objects.

10. GOVERNING BODY :-

The Governing Body's strength shall not be less than 7 and more than 15. The members of the Governing body shall hold the office for two years. The meetings of the Governing Body shall be held as and when necessary for which 15 days prior notice will be required and quorum shall be 2/3 rd.

11 ELECTION AND QUORUM:-

The general Body in its annual meeting will elect its president and all the office bearers, and members after two years by the secret ballot papers. The quorum of the General Body and the Governing Body shall be 2/3rd.

12. FUNCTIONS OF THE GOVERNING BODY



To arrange finance if required from another Banks Institutions or Individuals on reasonable terms and conditions and the Governing Body as a whole is liable for its return.

- b. The Governing Body shall make plan for the future programmes of the society.
- c. To appoint terminate and fix duties of any staff.
- d. The Governing Body shall meet at least once in a Month.

- Shall be entitled to participate in the meetings religious functions and the gatherings of the society.
- Shall have right to inspect the books of accounts minutes of proceedings of the General Meetings and register of members of the society on any working day during the business hours by giving a reasonable notice.

21. APPLICATION OF THE ACT:-

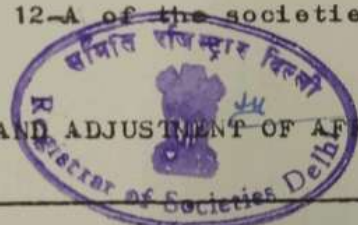
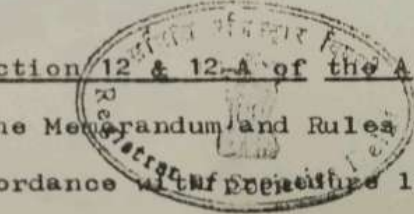

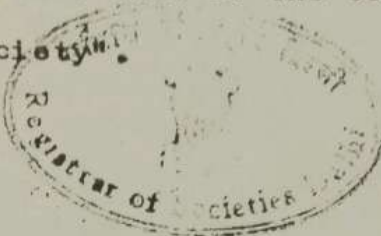
