

4. That the school shall comply with the provisions of Section 10(1) read with Rule 125 of DSEAR, 1973.
5. That the school shall observe the relevant provisions of DSEAR, 1973, RTE Act, 2009 and direction/instruction/guidelines issued by the department from time to time.
6. That the school shall comply with the orders/guidelines of DoE and judicial pronouncement w.r.t utilization/ maintenance of school funds.
7. That the school shall comply with the orders dated 07/11/2017/ guidelines of DoE and judicial pronouncement w.r.t. safety and security of the school children and take all steps to the effect.


